#### 1 INTRODUCTION

The Pleasant Oaks Landfill is a Type I solid waste disposal site located off of FM 3417, approximately 3,480 feet south of FM 127 in Titus County. The City of Mount Pleasant (City) was the original operator of the Landfill. In 1998, the City contracted the landfill's operations to Pleasant Oaks Landfill TX, LP, a Delaware limited partnership qualified to do business in Texas. Pleasant Oaks Landfill TX, LP's managing general partner is Allied Waste Landfill Holdings, Inc., which is an indirect, wholly-owned subsidiary of Republic Services (Republic). Republic is one of the leading solid waste management companies in the nation.

The permit is proposed to be transferred from the City of Mount Pleasant to Pleasant Oaks Landfill TX, LP. A general site location map is included in Appendix A. The Property Owner Affidavit, financial assurance, legal authority, and evidence of competency for Pleasant Oaks Landfill TX, LP, are included in Appendices B, C, D, and E, respectively. The Pleasant Oaks Landfill property owner will remain the City of Mount Pleasant. In addition, revised TCEQ forms 10400 and 20650 are included in Appendices F and G, respectively.







#### **Republic Solid Waste Sites**

The applicant, Pleasant Oaks Landfill TX, LP, is a subsidiary of Republic Services (Republic). Republic or its subsidiaries own, operate, or maintain a financial interest in the facilities identified in Tables E-1 and E-2. A listing of the state regulatory agencies for these facilities is provided in Table E-3. Republic acquires, operates, and develops nonhazardous waste disposal facilities on a national basis and is one of the largest providers of municipal waste services in the United States. Republic is a Delaware corporation whose shares are publicly traded on the New York stock exchange. As documented in Republic's 2017 Annual Report, no person or entity owns 20 percent or more of the company.

#### Pleasant Oaks Landfill TX, LP Key Personnel

#### Rich Kang, Area President

Mr. Kang is responsible for all hauling, transfer stations, and landfill operations in the South Texas area. Responsibilities include financial planning and environmental compliance, as well as other management responsibilities. Also, he oversees operations; sales and marketing; and finance for Republic's landfills, transfer stations, recycling, and waste collection operations.

#### Scott A. Trebus, Area Environmental Manager

Mr. Trebus is responsible for the engineering management, regulatory coordination, and environmental compliance of Republic's facilities within the South Area. He has several years of experience in environmental engineering related projects, which includes Texas MSW facilities.

#### James Murphy, General Manager

Mr. Murphy is responsible for operations of the Pleasant Oaks Landfill and other hauling and landfill facilities in the East Texas Area. Generally, Mr. Murphy's responsibilities include management of all operational aspects of these facilities, such as engineering, construction, environmental compliance, equipment maintenance, operational strategy, safety programs, financial planning and budgeting. Additionally, Mr. Murphy plays a key role in securing new permits and permit expansions, and he assists with community relations, as well as customer development.

#### **Austin Sparks, Environmental Manager**

Mr. Sparks has management and oversight responsibilities for environmental compliance at Republic's landfills, transfer stations, and hauling facilities in the North and East Texas areas. Mr. Sparks has primary responsibility for permitting and environmental compliance at the Pleasant Oaks Landfill.

#### Michael Sandifer, Operations Manager

Mr. Sandifer is responsible for the daily operations of the Maloy Landfill. His responsibilities include oversight of hourly employees, equipment maintenance, construction management, and operations compliance. Mr. Sandifer has a Texas Class A license for MSW Landfill Management and Operations.

#### **Equipment**

The following list of equipment is expected to be routinely available for use at the facility. Equipment requirements may vary in accordance with the method of landfill operations at any given time. Additional equipment will be provided as required for increasing volumes of incoming solid waste. Other equipment that provides the same function may be substituted on an as-needed basis.

# Equipment Description Landfill Compactor Excavator and Articulated Dump Truck (ADT) Track Dozer Motor grader Water Truck

The compactor will be used for spreading and compacting the refuse and also for compacting the cover material. The excavator and ADT are typically used for excavating the cover material and future disposal areas. The motor grader is typically used for road maintenance, ditching, surface water control, and final grading of the completed fill areas. The water truck will be used for dust control and moisture conditioning of soil materials.
